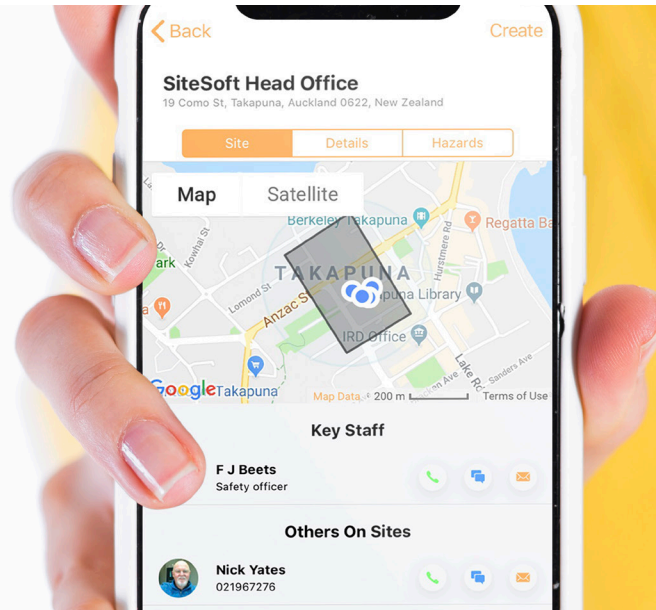

SiteConnect Geo-Fence is a robust, secure, and scalable solution built to automate and manage the sign-in/out process of your workforce across your sites.

Have you thought that there must be a better way to manage on-site activities but didn't know how?

SiteConnect enables registration of all regular site visitors, staff and contractors, and uses accurate Geo-Fence technology to automatically track, time and date-stamp access on and off properties via the GPS in your workforces phones.

The system records visitors as they come and go and the database securely stores relevant contractor certification or competency requirements.



Mobile App Technology

Smart use of Mobile App technology and Geo-Fencing gives you a real-time report on where your contractors are, for how long and when they left.



Visitor Management

SiteConnect automatically picks up when your workforce enter and leave a site with time and date stamped reporting of site entry and exits and an ability to 'see' a contractor on your property via the administrator's portal – particularly useful for larger properties.



Detailed Reports

Generate detailed reports over any site, see who has entered, the time they entered/exited, whether they acknowledged the induction material, their reason for visit, their contact information, and more.



QR Code Feature

As an optional feature QR codes can be utilized within a site linked to specific information and can be scanned from within the SiteConnect app to add more precision to the location of contractors.

Multiple Platform Options

- Utilize SiteConnect from your computer, smartphone, or tablet.
- Contractor's on-site need only to enable location services and have logged into the App once to receive site information automatically.



Automated Induction Management

- We ensure that all employees going on-site are presented with information that reduces health and safety risks.
- Induction material and hazards are automatically sent to a contractor's mobile device upon crossing the sites Geo-Fence, requiring real-time acknowledgment giving them the means to stay safe and avoid hazards.



Powerful Reporting

- The system will generate detailed reports for any site, log contractors entries/exits, time on-site, reason for visit, and more.
- See who is on a site at anyone time, access their information, documentation and contact details.



Protect Your Staff

- SiteConnect provides a level of mechanisms to protect your workforce, providing them with site-specific information, generate entrance reports, and know exactly who is on-site at all times.



Document Management

- Make documents required mandatory for upload e.g Photo ID, certifications and insurance.
- The system ensures that all documents that are loaded into the system remains current sending out notifications when the documents are about to expire.



Save Time

- Manual sign-ins/sign-outs are no longer required saving money by reducing wasted contractor time and associated chargeable costs.



Emergency Plans & Protocol

- Emergency plans are made accessible for those on-site through the SiteConnect App.
- Contractor or staff movements are visible for attendance certification or tracking in the event of a site evacuation.

Q&A FOR GEO-FENCE MODULE

What is Geo-Fencing?

Geo-Fencing is the term used for GPS tracking with virtual perimeters to identify when the device in question (or the contractor with the device) has entered or is near a particular point of interest (your site). SiteConnect harnesses Geo-Fencing technology to give back control to the site managers and PCBU's to streamline site access and create greater visibility over who is actually on your sites.

When should it be used?

Anytime really. Unlike other methods of registration when entering a place of work Geo-Fencing runs in the background making it harder for your workforce to not comply with your on-site registration process.

Why should you use it?

To remove the need to have a folder with all past paper-registers tucked away somewhere on the top-shelf corner in your site office. With the use of the SiteConnect mobile app and the GPS in your contractor's/employees phones it makes the site sign in and sign out processes simpler and streamlined by happening automatically. All data created through these actions is then securely stored in the cloud to be reported and actioned on when might need it most.

Who uses it?

It is beneficial for all SiteConnect mobile app users to sign into and out of sites automatically as controlling access and knowing who is on your site is one of the most important aspects of complying to the HSWA 2015.

How does this add to compliance on-site?

It means that at any one time you are able to identify who is on your site/'s and their general location. This is particularly beneficial in an emergency. Being tapped into SiteConnect's health & safety system also allows for mass communications with all workers who have signed into site giving you greater control than ever before.

You can now sit in one location and have real-time visibility over who is on all of your sites, what time they arrived, which company they are from and whether or not they have uploaded the relevant documentation required to allow them to legally do their work. This streamlines compliance making it easier than ever to manage your on-site activities.

What are the alternatives if I decide not to use the Geo-Fence?

If geo-fencing is not a viable option, QR codes can be utilised by contractors and employees scanning in and out of the site using the SiteConnect mobile app. Alternatively for those instances when contractors don't have mobile phones or visitors that aren't part of the SiteConnect ecosystem; we have developed the tablet-based SiteConnect Visitor Kiosk App. The SiteConnect Visitor Kiosk App along with QR codes gives you options depending on what you decide works best for your business.

Minimum Requirements

It is recommended to run the SiteConnect Mobile application on at least Android 8+ or iOS 10+. We do not recommend running it on older versions of Android and iOS.

For the best performance, it can be run on Android 10+ and iOS 13+.
